Rees2000 Program update for GST

All users of Rees2000 must update the program to a version of 01-Sep-2010@08:30 or newer before the change in GST on 01 October 2010.

Since the original GST update release of Rees2000 on 02-Jul-2010 we have fix a number of issues relating to the GST change that we missed with the earlier update. It is essential that you get another update of Rees2000 before 01 October 2010.

As part of the GST update we have reviewed all the customised programs that have been supplied to our clients. All of these programs have been updated to ensure that they comply with the change in GST. These updated custom programs have a version date of 01-Sep-2010@08:30 or later. If you have a custom extension program you must make sure that you download a version of the program dated 01-Sep-2010@08:30 or later.

Change to Rees AP from 1 October 2010

This month we will be emailing all Rees2000 users who pay by automatic payment with the new charge from 1 October 2010. The increase is solely GST related. All automatic payments from 1 October 2010 will need to be increased 2.222% to reflect this GST change.

Print Balance Forward Client Statements, even though they are set to be Open Item within Rees2000

You now have the ability to print B/Fwd statements for Open Item clients. This simplifies the statements, whilst still retaining the detailed information you require for account reconciliation in your system. The set up (14.14) password = SETUP, page 1 'Statements can print balance fwd', then set each client in (1.1) 'Print Statement Balance Fwd'

Email log

The event log (14.5) now has an extra field, E, being Email log. This logs all emails sent including who sent the email, who it was sent to, the subject, the attachments, the text body of the email and whether it was sent successfully.

To de-active this feature (14.14) password = SETUP, age 5, 'Write LOG record of emails sent?' change from Y to N.

Partial Summary invoices in Job Costing

Jobs can now be partially invoiced by summary, enabling you to select who to charge, what items to include on the invoice and then type what you want on the invoice, including sell prices. This offers greatly flexibility in invoicing jobs, with the options available now (full detailed, summary, summary by type, summary by group, summary with quote details, partial detailed and now partial summary)

Print current statement directly from client set up

You can now print the client's statement directly from their set up screen (1.1) by selecting the] symbol.

New Stock report— Stock Movements by Date

(2.11.42) is the new report location to enable stock movements to be printed and totalled by date range selected.
